## By-Laws Membership Application Procedures and Requirements for All applicants:

- Submit an updated completed application to:
  - sent by mail to PO Box 431, Hackettstown, NJ 07840
  - o at a regular monthly business meeting to the Membership Committee.
    - Membership Committee available from 7:00 PM to7:30 PM only.
- You must attend 2 of the next 3 consecutive monthly meetings once notified.
  - o At 1st meeting, your application will be processed & you will become eligible.
    - Full Membership Fees are due at this time (see table below)
  - At 2<sup>nd</sup> meeting, you will be voted upon for a one-year probationary membership.
    - Range Orientation must be completed prior to Probationary Vote
  - Possess a valid New Jersey Firearms Identification card (NJFID)
  - Be a current member of the National Rifle Association (NRA).
- Range Orientations start at 9:00 AM, the Saturday immediately after a regular meeting at the range club house. Independent Range use is prohibited until completed.
- Regular Monthly Club Meetings start promptly at 7:30 PM, the third Wednesday of every month at the Elks Lodge, 201 Howard Boulevard, Mt. Arlington, NJ.
  - Directions to Elks Lodge: Route 80 to Exit #30 (Howard Boulevard), north one mile on the left (just past the Pub 199 restaurant) the Elks Lodge is on the left.
- As per SSA By-Laws, failure to comply with any of the above will void this application.
